

## Carlisle's Long Term Growth Fund FCP SIF wins Insurance Fund of the Year in the Investor Choice Awards 2015

*London, 27th March 2015* - HedgePo, has announced the winners of its Investors Choice Awards 2015 for the EMEA region. The annual Investors Choice Awards honors fund managers that have achieved outstanding risk adjusted absolute returns. This year, Carlisle Management proudly received the 2014 Insurance Fund of the Year for its Luxembourg Life Fund: Long Term Growth Fund FCP SIF.

Award finalists were honored and the winners announced at a gala dinner at the prestigious Dorchester Hotel in London. Scores for the qualitative and quantitative sets of criteria are then calculated and combined in equal measure to reach the total score. This total score determines the winner in each category.

Carlisle happily accepted the award for Best Insurance Fund of 2104.
